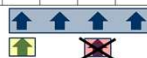

What is in the NPA 2017-10 ?



- GENERAL REQUIREMENTS (ATM/ANS.OR.A)
 - GM on CA-SP coordination
 - GM on SP to facilitate oversight
- Non-ATSP and ATSP
 - AMC on “SW Safety Assessment System”
 - GM on reference to Standard Documents: ED109A, ED153...

What is in the NPA 2017-10 ?



NB: GM only



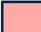
- Non-ATSP
 - SWAL (allocation ?) expected as part of the Specifications
- ATSP
 - SWAL allocation as part of the S.A. - ?Severity Classification Scheme?
 - SWAL as an input to the Specifications (when applicable)

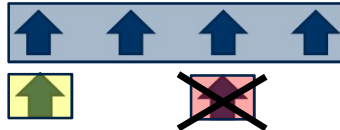
Open issues – SWAL allocation



■ Which Severity Classification Scheme?

Open issues – SWAL Allocation



- Allocation : other approaches discussed
 - Use of other Allocation Tables (occurrence ?)
 - Notion of "Service Assurance Level"

What is clear:

- ATSP and Non-ATSP will have to have SWALs
- This will apply to MET-SP

Open issues – SA/SSA



- Coordination between ATSP and NON-ATSP
 - Specifications / Behaviour requirements
 - Demonstration of SWAL
 - Building the assurance documentation
 - Owning the responsibility
